**Swallow Hill Music experienced another great year in 2014 with continued growth and expansion of our programming efforts and overall visits across all program areas increasing by more than 7 percent. Our concerts attracted more than 92,000 patrons at our Yale Avenue location and at venues throughout the Front Range. Our music school hosted more than 51,000 visits through 950 8-week group music classes and 9,000 private lessons. In early 2014, the school opened its first satellite location in Denver's Lowry neighborhood. This location has continued to perform well beyond initial expectations, and the success led to the opening of a second satellite location in the Highlands neighborhood in the spring of 2015.**
