Swallow Hill Music experienced another great year in 2015 with continued growth and expansion of our programming efforts as overall visits across all program areas increased by more than 6%. Our concerts attracted nearly 94,000 patrons at our Yale Avenue location and at venues throughout the Front Range. Our music school hosted more than 56,000 visits through 957 8-week group music classes and 12,000 private lessons. In early 2015, the school opened its second satellite location in Denver's Highlands neighborhood. This, and our first satellite location in Denver's Lowry neighborhood have performed well beyond initial expectations. Swallow Hill Music also continued to prioritize providing unique music experiences to underserved communities in 2015. We granted \$34,000 in Scholarships (a 40%
