Public Inspection Requirement

INCLUDING FOUR MILE HISTORIC PARK, THE SUMMER CONCERT SERIES AND
EVENINGS AL FRESCO AT DENVER BOTANIC GARDENS. WE ALSO PARTNERED WITH
ORGANIZATIONS SUCH AS THE CLYFFORD STILL MUSEUM, CLAYTON EARLY LEARNING
AND BUTTERFLY PAVILION TO BOOK AND PROMOTE MUSICAL ACTS FOR THEIR
EVENTS. IN TOTAL, THROUGH CONCERT PROGRAMMING, SWALLOW HILL MADE OVER
45,000 MUSICAL CONNECTIONS. OUR CONCERTS HIGHLIGHTED INTERNATIONAL,
